

# CONSENT TO PERSONAL DATA PROCESSING

## 1. General provisions

1.1. By this consent, in accordance with the Federal Law of 27 July 2006 No 152-FZ On Personal Data, **I, personal data subject, hereinafter referred to as the “User”**, freely, of my own will and in my own interest, as well as confirming my legal capacity, hereby give the Autonomous Non-profit Organization World Youth Festival Directorate (hereinafter referred to as ANO WYFD) (OGRN (Primary State Registration Number) 1237700328194, INN (Taxpayer Identification Number) 9704210995), registered at the following address: 121099, Moscow, Novinsky Boulevard, building 3, structure 1, (hereinafter referred to as the “Operator”) my consent to the processing of my personal data.

1.2. List of personal data, to the processing of which this consent shall be given:

1.3. List of actions with personal data to which the consent of the personal data subject shall be given, general description of the methods of personal data processing used by the Operator and the above-mentioned persons:

- processing of the above-mentioned personal data shall be carried out through automated and non-automated (mixed) processing of personal data;
- actions performed with personal data: collection, recording, arrangement, accumulation, storage, specification (updating, changing), extraction, use, transfer (provision, access), blocking, removal, destruction of personal data.

## **2. Purpose of personal data processing**

2.1. The processing of personal data of Platform users shall be carried out for the purposes of:  
– registering on the <https://wyffest.com/> Platform and providing users with access to the functionality;

– providing users with the opportunity to register, pass the selection process and participate in the Operator's events;

– providing service support as part of the Operator's events, including:

- visa support;
- purchase of travel tickets;
- accommodation;
- meals;
- medical insurance.

– ensuring accreditation of users for the Operator's events;

– compiling analytical reports and statistical data on users by territorial, age and other criteria.

2.2. The Operator may transfer personal data to:

– partners and co-organizers of projects and (or) events held by the Operator, specified in the regulatory documents governing realization of relevant projects and (or) events.

2.3 In addition to the above-mentioned purposes, transfer of personal data of the Platform users to third parties shall be possible if the transfer is necessary as part of the procedure established by the legislation of the Russian Federation.

## **3. Responsibilities of the Operator**

3.1. To observe the principles of rules of personal data processing stipulated by the Federal Law of 27 July 2006 No 152-FZ On Personal Data.

3.2. To carry out processing of personal data in accordance with the purposes defined by the Parties in the agreement.

3.3. To observe confidentiality of personal data, take necessary measures aimed at ensuring fulfilment of obligations stipulated by the Federal Law of the Russian Federation of 27 July 2006 No 152-FZ On Personal Data (including ensuring security of personal data during their processing, as well as observing the requirements for the protection of processed personal data), to comply with the requirements stipulated by Part 5 of Article 18 and Article 18.1 of the Federal Law of 27 July 2006 No 152-FZ On Personal Data.

## **4. Storage period of personal data and method of its withdrawal**

4.1. This consent to the processing of personal data shall be valid from the moment of its submission to the Operator until achieving the purposes of the processing and it may be withdrawn by the personal data subject at any time by submitting to the Operator ([help@wyffest.com](mailto:help@wyffest.com)) an application in electronic and (or) written form with a request to stop the processing of their personal data on the Platform.

4.2. Subject's personal data shall be stored for the period established by the legislation of the Russian Federation. Personal data shall be destroyed: upon achieving the purposes of the personal data processing; upon liquidation or reorganization of the Operator; based on a written application of the personal data subject with a request to stop the processing of their personal data (the Operator shall stop the processing of such personal data within 3 (three) working days, which the personal data subject shall be notified of in writing within 10 (ten) working days).
